#### **DESCRIPTION**

Each Single Effect Distiller is both a Still and a Pure Steam Generator. The distiller produces dry, saturated steam. When the Pure Steam, is condensed through a double tube sheet condenser. The steam is purified using centrifugal and gravity separation methods. it meets the requirements of all international pharmacopoeias for Water-for-Injection. Therefore the system can provide alternately production of Pure Steam or Water for Injection. The Single Effect Distillers are traditionally installed where small capacities are needed when there are significant budget constraints. The production process consists of purified water evaporation followed by pure steam separation and condensation. The steam is purified using centrifugal and gravity separation methods.
